Dr Yolana Pringle - Vitae

Dr Yolana Pringle is Policy and Evidence Manager at Vitae, where she leads on activities that create impact from Vitae's expertise on researcher development and research culture. This includes responsibility for the Vitae Policy Advisory Group, development of Vitae's policy positions and involvement with the HR Excellence in Research Award and Researcher Development Concordat. She has an academic background, with over 10 years' international research experience, as well as leadership of a national subject association. Yolana's further interests include equity in international research partnerships and researcher wellbeing and mental health.

Dr Cathal Rogers – The University of Manchester

Dr Cathal Rogers is Researcher Development Manager at the University of Manchester, which has a diverse community of around 1800 post-doctoral researchers.
